Resolved, as it is hereby resolved, to approve the installation of a heroic marker for the late PFC Peter John Villanueva.

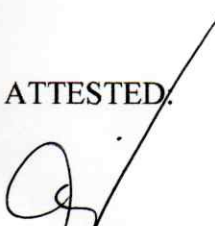

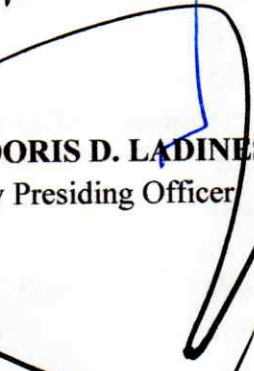
