RESOLUTION NO. 12-2026

RESOLUTION INTERPOSING NO OBJECTION TO THE OPERATION OF ONE UNIT OF FISH CORRAL/BAKLAD LOCATED AT PUROK 2, BANGAN, BOTOLAN, ZAMBALES OWNED BY THE ALIMBUHABO FISHERFOLKS ASSOCIATION

Whereas, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates Local Government Units to promote the general welfare and ensure the delivery of basic services, including the regulation of livelihood within their jurisdiction;

Whereas, Section 17 of Republic Act No. 8550 (The Philippine Fisheries Code of 1998) grants the Sangguniang Bayan authority to grant fishery privileges within municipal waters;

Whereas, the Alimbuhabo Fisherfolks Association through its Chairman, Mr. Reny P. Correa has formally requested the Sangguniang Bayan for a resolution of no objection for the operation of one (1) unit of fish corral (baklad) situated at the coastal waters of Purok 2, Bangan, Botolan, Zambales;

Whereas, the Office of the Sangguniang Bayan is in receipt of an endorsement letter dated February 9, 2026 from the Chairman of the Municipal Fisheries and Aquatic Resources Management Council, which stipulates that the Alimbuhabo Fisherfolks Association had complied with the requirements for Lambaklad Registration;

Whereas, the Barangay Council of Bangan has expressed its support through the passage of Resolution No. 01-2026 entitled "Resolution Interposing No Objection of Lambaklad Located at Purok 2, Bangan, Botolan, Zambales/Zone 4 Fishing Ground Owned by Alimbuhabo Fisherfolks Association, Inc" dated January 2, 2026;

Whereas, the proposed location and operation of the said fish corrals have been reviewed and found to be compliant with existing local environmental laws and maritime safety regulations, provided that they do not obstruct designated navigational lanes;

Now therefore, upon motion of Hon. Arthur R. Daria, Chairman of the Committee on Agriculture, duly seconded by Hon. Eddie D. Daos, and approved by all the members in session assembled, be it:

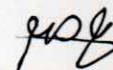

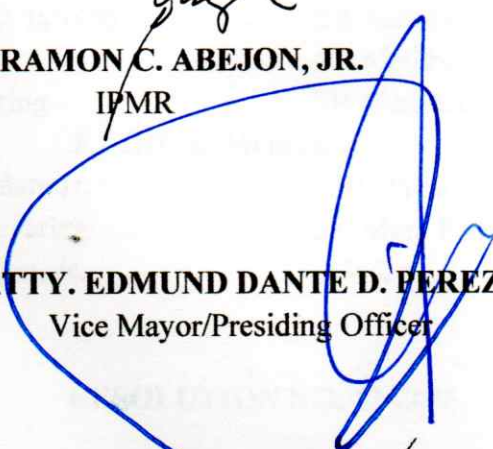
