**RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REPRESENTED BY ITS REGIONAL DIRECTOR, MS. MARITES M. MARISTELA, CESO III, FOR THE IMPLEMENTATION OF VARIOUS PPAs FOR POVERTY REDUCTION PROGRAMS AND SOCIAL PROTECTION PROGRAMS IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES**

**Whereas**, it is the declared policy of the State to promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services;

**Whereas**, the Department of Social Welfare and Development (DSWD), is the primary government agency mandated to develop, implement, and coordinate social protection and poverty reduction solutions for and with the poor, vulnerable and disadvantaged;

1. Pantawid Pamilyang Pilipino Program
2. Sustainable Livelihood Program
3. Disaster Response Management
4. Social Pension Program for Indigent Senior Citizens
5. Assistance to Individuals in Crisis Situation (AICS)
6. Supplementary Feeding Program
7. Technical Assistance and Resource Augmentation
8. Comprehensive Program for Street Children, Street Families, especially indigenous people
9. KC-KCNDP and/or KC KKB
10. Replication of completed Social Technology Projects, and
11. Recovery Reintegration Program for Trafficked Persons

**Now therefore**, upon motion of Hon. Dr. Fernando D. Igrobay, seconded by Hon. Arthur R. Daria, and approved by all the members in session assembled be it;

**Resolved**, as it is hereby resolved, to authorize Hon. Jun Omar C. Ebdane, Municipal Mayor, to enter into a Memorandum of Agreement with the Department of Social Welfare and Development (DSWD), represented by its Regional Director, Ms. Marites M. Maristela, CESO III, for the implementation of various PPAs for poverty reduction programs and social protection programs in the Municipality of Botolan, Zambales.

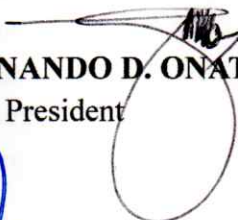

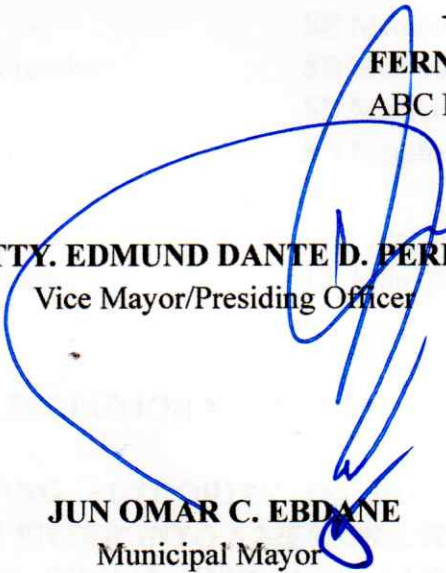
