RESOLUTION EARNESTLY REQUESTING THE ESTATE MANAGEMENT COMMITTEE (EMC) TO INCLUDE AS VOTING MEMBERS THE SANGGUNIANG BAYAN CHAIRPERSONS OF THE COMMITTEE ON LAND UTILIZATION, COMMITTEE ON MARKET, TRADE AND INDUSTRY, AND COMMITTEE ON BARANGAY AFFAIRS

Whereas, the Municipal Estate Management Committee, under the leadership of the Municipal Mayor, Hon. Jun Omar C. Ebdane, is tasked with overseeing, regulating, and managing the real property assets, land developments, and municipal estates of the Local Government Unit of Botolan;

Whereas, sound municipal property administration requires close coordination between the Executive and Legislative branches to ensure that policy formulation, land allocation, and local commercial development align with community needs and statutory guidelines;

Whereas, the Committee on Land Utilization plays a critical role in zoning, land use policies, and sustainable spatial development within the Municipality;

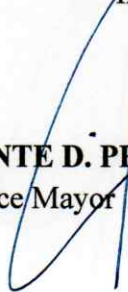
