Whereas, Dr. Peter Allen Sescon, Chief of Hospital of the Dr. Florentino C. Doble Memorial Hospital (DFCDMH) has formally requested the retention of Ms. Alma Marie V. De Guzman, Medical Technologist I, at DFCDMH to ensure the uncompromised and continuous delivery of essential laboratory and healthcare services;

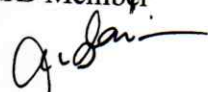

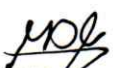

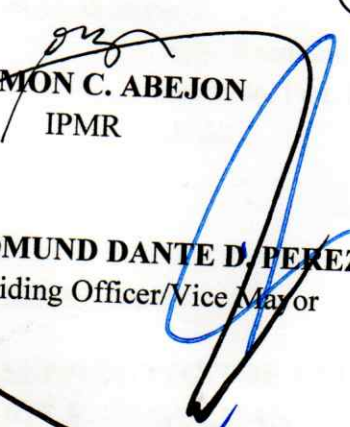
