RESOLUTION APPROVING THE ANNUAL BUDGET OF BARANGAY SAN JUAN FOR CY 2026 AMOUNTING TO SIXTEEN MILLION FOUR HUNDRED TWENTY-TWO THOUSAND ONE HUNDRED EIGHTY-ONE PESOS (P 16, 422,181.00)

Whereas, the proposed Annual Budget for Fiscal Year 2026 of Barangay San Juan amounts Sixteen Million Four Hundred Twenty-Two Thousand One Hundred Eighty-One Pesos (P 16,422,181.00) to covering the estimated income and programmed appropriations for the effective delivery of basic services and implementation of development programs, projects, and activities of the barangay;
