RESOLUTION APPROVING THE UTILIZATION OF THE SANGGUNIANG KABATAAN FUNDS OF BARANGAY MAGUISGIS MUNICIPALITY OF BOTOLAN, ZAMBALES FOR FISCAL YEAR 2025 IN THE AMOUNT OF EIGHTY-TWO THOUSAND PESOS (P82,000.00)

Whereas, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan is mandated to review and approve the annual budget of component barangays to ensure that the same are in conformity with existing laws, rules and regulations;

Whereas, the proposed Utilization of Funds for Fiscal Year 2025 of Sangguniang Kabataan of Barangay Maguisgis amounts **Eighty-Two Thousand Pesos (P82,000.00)** to covering the estimated income and programmed appropriations for the effective delivery of basic services and implementation of development programs, projects, and activities of the barangay;

Whereas, after careful review, the proposed utilization of funds of Sangguniang Kabataan of Barangay Maguisgis for Fiscal Year 2025 was found to be in accordance with the provisions of the Local Government Code of 1991, applicable budgeting laws, rules and regulations;
