RESOLUTION GRANTING AUTHORITY TO MR. NOEL C. CLIMACO, ASSISTANT MUNICIPAL TREASURER, TO ACT AS SIGNATORY IN ALL MONEY TRANSACTIONS OF THE LGU-BOTOLAN WITH THE LANDBANK OF THE PHILIPPINES-IBA BRANCH EFFECTIVE JANUARY 2026

Whereas, the Local Government Unit of Botolan maintains various depository accounts with the Landbank of the Philippines-Iba Branch for its operational funds, developmental projects, and trust accounts;

Whereas, to ensure the continuous and efficient delivery of public services, as well as the timely processing of financial obligations, payroll, and other disbursements, there is a need to designate authorized signatories for the LGU's bank transactions;

Whereas, Mr. Noel C. Climaco, in his capacity as the Assistant Municipal Treasurer, possesses the necessary qualifications and official mandate to handle the municipality's fiscal matters;

Whereas, the designation of Mr. Noel C. Climaco as an authorized signatory is vital for the administrative exigency of the Municipal Treasury Office, particularly in the signing of checks, withdrawal slips, fund transfers, and other pertinent financial documents;
