RESOLUTION NO. 55-2026

RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A CONTRACT OF USUFRUCT WITH PANAN NATIONAL HIGH SCHOOL, PANAN, BOTOLAN, ZAMBALES TO FORMALIZE THE SCHOOL'S OCCUPANCY AND PROVIDE A CLEAR FRAMEWORK FOR ITS CONTINUED USE OF MUNICIPAL LAND FOR EDUCATIONAL PURPOSES

Whereas, education is a vital pillar for community development, and the Municipal Government of Botolan is deeply committed to supporting educational institutions that foster the academic advancement and welfare of its youth;

Whereas, the Panan National High School (PNHS) located in Barangay Panan, Botolan, Zambales, is a public secondary school dedicated to providing accessible and quality education to the constituents of the municipality;

Whereas, a specific parcel of land owned by the Municipal Government in Purok 6 at Barangay Panan, covered by Tax Declaration No. 01-012-02-210 with a total land area of approximately 5,894 square meters, is presently occupied by the Panan National High School for its campus, classroom, facilities, and general educational operations;

Whereas, while the school has long enjoyed the beneficial use of the property, there is an urgent need to execute a formal Contract of Usufruct to legally formalize the school's occupancy, ensure strict compliance with applicable legal and administrative requirements of both the Department of Education (DepEd) and the local government, and establish a clear framework for its long-term continued use;

Whereas, Section 22 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that no elective local official may enter into a contract, agreement, or deed of donation on behalf of the local government unit without prior authorization from the Sangguniang Bayan;

Now therefore, on motion of Hon. Eddie D. Daos, duly seconded by Hon. Dr. Fernando D. Igrobay, and approved by all the members in session assembled;

Be it resolved, as it is hereby resolved, by the Sangguniang Bayan of Botolan, Zambales, to authorize Hon. Jun Omar C. Ebdane, Municipal Mayor, to enter into, sign and execute a Contract of Usufruct with the Panan National High School, represented by its proper school authorities, covering the parcel of land presently occupied and utilized by the school in Barangay Panan, Botolan, Zambales.

Resolved further, that the execution of this Usufruct agreement shall formalize the school's long-standing occupancy, ensure compliance with all governing statutory and administrative regulations, and establish a clear, structured legal framework to protect the school's facilities and secure its continued operations for educational purposes.

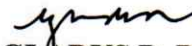
Resolved finally, that copies of this resolution be furnished to all concerned offices and agencies for their information and appropriate action.
