RESOLUTION NO. 54-2026

RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO DONATE SIX HUNDRED TWENTY (620) SQUARE METERS OF LAND TO THE BUREAU OF FIRE PROTECTION-BOTOLAN INTENDED FOR THE CONSTRUCTION OF A NEW BFP STATION BUILDING IN TAMPO, BOTOLAN, ZAMBALES, AND EXPLICITLY REVOKING A PREVIOUS LAND DONATION EXTENDED TO THE SAME AGENCY IN BARANGAY BATONLAPOC

Whereas, the Bureau of Fire Protection (BFP) plays a vital role in safeguarding the lives, properties, and livelihoods of the people of Botolan by ensuring public safety, fire prevention, and efficient emergency response operations;

Whereas, to improve its services and effectively accommodate modern firefighting equipment and personnel, the BFP Botolan is in urgent need of a more suitable and strategically located site for the construction of a new state-of-the-art BFP Building;

Whereas, the Municipal Government of Botolan is the absolute and registered owner of a certain parcel of land situated in Barangay Tampoc, Botolan, Zambales and has identified a portion measuring six hundred twenty (620) meters as ideal and highly conducive to the operational demands of the BFP;

Whereas, the LGU of Botolan had previously authorized and executed a donation of a different parcel of land measuring four hundred square meters in Barangay Batonlapoc for the use of BFP, which upon subsequent technical evaluation and administrative reassessment, has been deemed less suitable or superseded by the newly identified site;

Whereas, Section 22 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that no elective local official may enter into a contract, agreement, or deed of donation on behalf of the local government unit without prior authorization from the Sangguniang Bayan;

Now therefore, on motion of Hon. Eddie D. Daos, duly seconded by Hon. Dr. Fernando D. Igrobay, and approved by all the members in session assembled;

Be it resolved, as it is hereby resolved, by the Sangguniang Bayan of Botolan, Zambales, to authorize Hon. Jun Omar C. Ebdane, Municipal Mayor, to sign, execute, and deliver a deed of donation and all necessary documents for the transfer and donation of a six hundred twenty (620) square meter parcel of land located in Barangay Tampo, Botolan, Zambales intended exclusively for the construction of the new BFP Building.

Resolved further, that the previous authorization, commitment and deed of donation concerning a prior parcel of land granted by the Municipal Government of Botolan to the BFP located in Barangay Batonlapoc is hereby expressly revoked, reconveyed and rendered null and void, effectively returning full ownership and possession of the said prior lot to the LGU Botolan.

Resolved finally, that copies of this resolution be furnished to all concerned offices and agencies for their information and appropriate action.

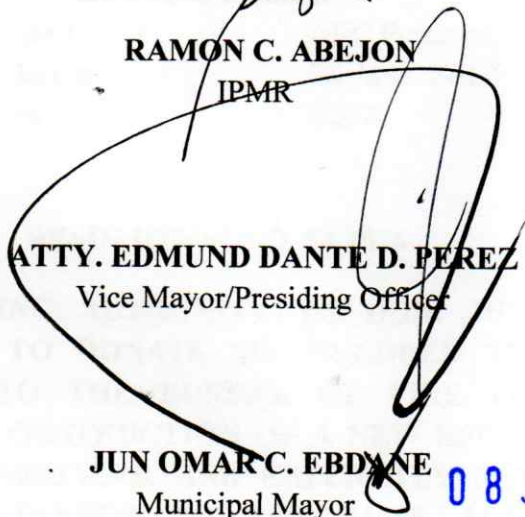
