RESOLUTION APPROVING THE SUPPLEMENTAL BUDGET NOS. 4 AND 5 AND THE UTILIZATION OF 5% LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND AMOUNTING TO P1,023,833.04, P549,645.00 AND P460,000.00 OF BARANGAY PAUDPOD MUNICIPALITY OF BOTOLAN, ZAMBALES FOR FISCAL YEAR 2026

Whereas, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan is mandated to review and approve the annual budget of component barangays to ensure that the same are in conformity with existing laws, rules and regulations;

Whereas, the Supplemental Budget No.4 and 5 and Utilization of 5% of Local Disaster Risk Reduction Management Fund of Barangay Paudpod has duly enacted for Fiscal Year 2026 and submitted the same to the Sangguniang Bayan for review and approval;

Whereas, the proposed Supplemental Budget Nos. 4 and 5 and Utilization of 5% of Local Disaster Risk Reduction Management Fund of Barangay Paudpod. for Fiscal Year 2026 of Barangay Paudpod amounts to:

Supplemental Budget No. 5 – P 549,000.00

Utilization of 5% LDRRMF – P 460,000.00

covering the estimated income and programmed appropriations for the effective delivery of basic services and implementation of development programs, projects, and activities of the barangay;
