RESOLUTION NO. 59-2025

RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT FOR THE INTER-LGU COOPERATION WITH THE PROVINCIAL GOVERNMENT OF ZAMBALES AND THE MUNICIPAL GOVERNMENT OF SUBIC, CASTILLEJOS, SAN MARCELINO, SAN ANTONIO, SAN NARCISO, SAN FELIPE, CABANGAN, IBA, PALAUIG, MASINLOC, CANDELARIA AND STA. CRUZ FOR THE INTEGRATION OF LOCAL HEALTH SYSTEMS INTO PROVINCE-WIDE HEALTH SYSTEM (PWHS) IN THE PROVINCE OF ZAMBALES

Whereas, the Office of the Sangguniang Bayan is in receipt of a proposed Memorandum of Agreement for Inter-LGU Cooperation of the thirteen (13) municipalities in Zambales for the integration of local health systems into Province-wide Health System;

Whereas, on October 6, 2025, Dr. Noel Bueno, the Provincial Health Officer, served as resource speaker during the Sanggunian's regular session, and explained all the particulars and complete information about the Province-wide Health System;

Whereas, the Department of Health (DOH) and the Department of the Interior and Local Government (DILG) have jointly issued guidelines to strengthen and integrate local health systems into province-wide health systems to ensure the delivery of accessible, efficient, and equitable health services to all;

Whereas, the Province of Zambales, through the leadership of the Provincial Government, seeks to establish an integrated and harmonized health system across all municipalities, ensuring coordinated health planning, financing, and service delivery;

Whereas, the proposed Memorandum of Agreement on Inter-LGU Cooperation aims to formalize the participation and commitment of the Municipality of Botolan with the Provincial Government of Zambales and the Municipal Governments of Subic, Castillejos, San Marcelino, San Antonio, San Narciso, San Felipe, Cabangan, Iba, Palauig, Masinloc, Candelaria, and Sta. Cruz in the implementation and integration of the Local Health Systems into a Province-wide Health System;

Whereas, to effect this cooperation, it is necessary to grant authority to Hon. Jun Omar C. Ebdane, Municipal Mayor of Botolan, to represent the Municipality and sign the said Memorandum of Agreement on its behalf;

Now therefore, upon motion of Hon. Dr. Fernando D. Igrobay, seconded by Hon. Arthur R. Daria, and approved by all the members in session assembled be it:

Resolved, as it is hereby resolved, to grant authority to Hon. Jun Omar C. Ebdane, Municipal Mayor, to Enter Into a Memorandum of Agreement for the Inter-LGU Cooperation with the Provincial Government of Zambales and the Municipal Government of Subic, Castillejos, San Marcelino, San Antonio, San Narciso, San Felipe, Cabangan, Iba, Palauig, Masinloc, Candelaria and Sta. Cruz for the Integration of Local Health Systems into Province-Wide Health System (PWHS) in the Province of Zambales.

Resolved further, that copies of this resolution be furnished to all concerned departments and agencies for their information and appropriate action.
