RESOLUTION NO. 24-2026

RESOLUTION APPROVING THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT INVESTMENT PLAN AND ITS SUPPLEMENTAL ANNUAL INVESTMENT PLAN TO PROGRAM THE PROPOSED PROCUREMENT OF ONE (1) UNIT OF BULLDOZER AMOUNTING TO ELEVEN MILLION TWO HUNDRED FIFTY THREE THOUSAND SIX HUNDRED FOURTEEN PESOS (PHP11,253,614.00) TO BE FUNDED BY THE 5% LDRRMF-SPECIAL TRUST FUND WHICH INCLUDES THE UNEXPENDED BALANCE (PHP9,903,614.00) AND REVERSION OF APPROPRIATION PROGRAMMED FOR GOODS AND OTHER SUPPLIES FOR STOCKPILING (PHP1,000,000.00) AND MDRRM SUPPLIES AND EQUIPMENT (PHP350,000.00)

Whereas, the Municipal Disaster Risk Reduction and Management Council (MDRRMC) has identified the urgent need to acquire heavy machinery to enhance the municipality's capacity for disaster prevention, mitigation, and post-disaster rehabilitation;

Whereas, a primary requirement identified is the procurement of one (1) unit of bulldozer, which is essential for clearing operations, slope stabilization, and the maintenance of critical infrastructure during and after natural calamities;

Whereas, the total estimated cost for the said procurement is P11,253,614.00 to be sourced from the accumulated 5% Local Disaster Risk Reduction and Management Fund (LDRRMF) Special Trust Fund;

Whereas, the funding strategy for this procurement involves the consolidation of the following fund sources:

1. Unexpended Balance from the Special Trust Fund in the amount of P9,903,614.00
2. Reversion of Appropriation originally programmed for Goods and Other Supplies for Stockpiling in the amount of P1,000,000.00
3. Reversion of Appropriation originally programmed for MDRRM Supplies and Equipment in the amount of P350,000.00

Whereas, the MDRRMC has recommended the adjustment of the investment plan to prioritize this capital outlay, ensuring that the municipality is better equipped to protect the lives and properties of its constituents;

Now therefore, upon motion of Hon. Dr. Fernando D. Igrobay, duly seconded by Hon. Eddie D. Daos, and approved by all the members in session assembled;

Be it resolved, as it is hereby resolved, to approve the Municipal Disaster Risk Reduction and Management Investment Plan (MDRRMIP) and its Supplemental Annual Investment Plan for the procurement of one (1) unit of Bulldozer, with the following funding breakdown:

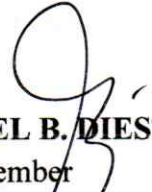

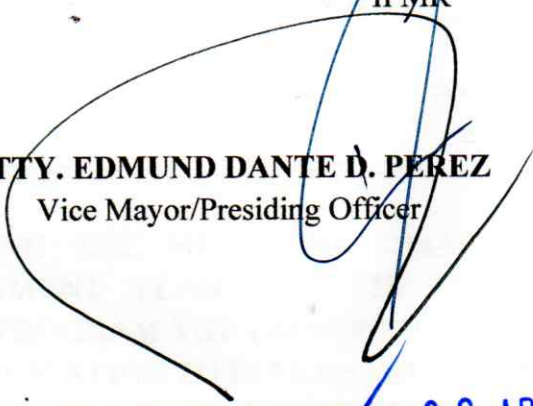

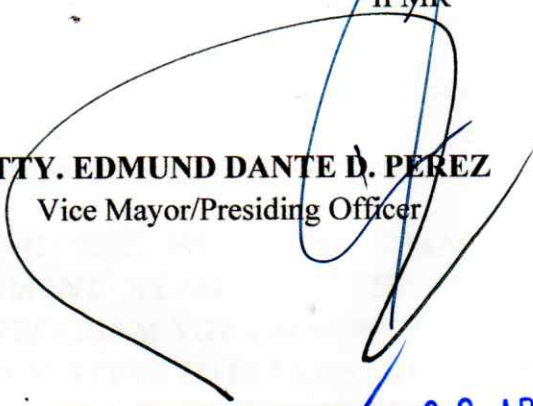
