RESOLUTION NO. 49-2025

RESOLUTION ENDORSING THE APPOINTMENT OF MR. JOSHUE A. QUILALANG AS THE NEW PRESIDENT OF THE OFFICE OF THE SENIOR CITIZENS AFFAIRS (OSCA) OF THE MUNICIPALITY OF BOTOLAN, ZAMBALES

Whereas, pursuant to Republic Act No. 9994, otherwise known as the “Expanded Senior Citizens Act of 2010”, every municipality is mandated to establish an Office of the Senior Citizens Affairs (OSCA), headed by a duly appointed President from among the senior citizens of the locality;

Whereas, the said office plays a vital role in advancing the welfare, rights, and privileges of senior citizens and in ensuring that programs and services intended for them are properly implemented;

Whereas, the Municipal Social Welfare and Development Office submitted a list of three (3) nominees who will vie for the position of OSCA President, to the Office of the Sangguniang Bayan on August 29, 2025;

Whereas, the members of the Sangguniang Bayan then selected via secret balloting, the OSCA President who shall serve for a term of three (3) years without reappointment but without prejudice to an extension if exigency so requires;
