RESOLUTION AUTHORIZING HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND A SPECIFIC IMPLEMENTATION ARRANGEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR THE IMPLEMENTATION OF DSWD-KALAHYAN CIDSS UNDER THE PANAHON NG PAGKILOS: PHILIPPINE COMMUNITY RESILIENCE PROJECT (PCRP) AND ACTIVITIES IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES

Whereas, the Department of Social Welfare and Development (DSWD) is implementing the KALAHYAN-CIDSS (Kapit-Bisig Laban sa Kahirapan-Comprehensive and Integrated Delivery of Social Services), a community-driven development program aimed at empowering communities and improving local governance;

Whereas, the Panahon ng Pagkilos: Philippine Community Resilience Project is a strategic initiative designed to strengthen the capacity of local government units to prepare for, respond to, and recover from natural disasters and climate change impacts;

Whereas, the Municipality of Botolan recognizes the need to enhance community resilience and provide sustainable social services to its constituents through the technical and financial support provided by the DSWD;

Whereas, for the formal implementation of the project, it is a prerequisite for the Local Government Unit (LGU) to enter into a memorandum of agreement and a specific implementation arrangement outlining the roles, responsibilities, and budgetary commitments of both DSWD and the LGU;

Whereas, the Sangguniang Bayan finds the project highly beneficial to the general welfare of the people of Botolan, as it aligns with the municipal agenda for disaster risk reduction and poverty alleviation;

Now therefore, upon motion of Hon. Dr. Fernando D. Igrobay, duly seconded by Hon. Arthur R. Daria, and approved by all the members in session assembled, be it:

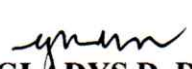

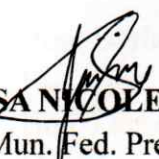

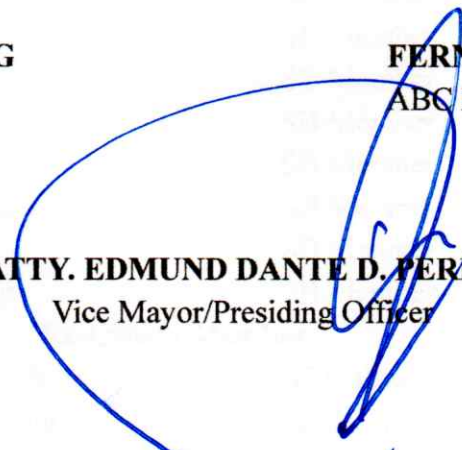
