RESOLUTION NO. 53-2025

RESOLUTION AUTHORIZING HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A DATA TURNOVER AGREEMENT WITH THE PHILIPPINE STATISTICS AUTHORITY (PSA) REPRESENTED BY ITS UNDERSECRETARY, NATIONAL STATISTICIAN AND CIVIL REGISTRAR GENERAL, CLAIRE DENNIS S. MAPA, PHD., PURSUANT TO REPUBLIC ACT NO. 11315 IN THE ESTABLISHMENT OF COMMUNITY-BASED MONITORING SYSTEM, IN THIS MUNICIPALITY

Whereas, the Community-Based Monitoring System (CBMS) was established and instituted in every city and municipality as an economic and social tool for the formulation and implementation of poverty alleviation and development programs that are specific, targeted, and responsive to the basic needs of each sector of the community pursuant to Republic Act No. 11315 or the Community-Based Monitoring System Act;

Whereas, pursuant to PSA Board Resolution No. 04, Series of 2024, a simultaneous conduct of the 2024 Census Population (POPCEN) and CBMS shall be conducted from July to September 2024 to update the mid-decade inventory of the population of the entire Philippines and update the social registries of national government agencies and local government units for evidence-based project development and program implementation;

Whereas, RA 11315 provides that the cities and municipalities can maintain their CBMS database for local-level planning and program implementation, and the PSA shall receive and store all aggregated data gathered by the cities and municipalities to create a national CBMS databank;

Whereas, the PSA as the lead agency in the implementation of RA 11315 shall undertake measures to ensure the integrity and safety of the gathered information against unnecessary leakage and access by unauthorized persons;

Whereas, the PSA shall turnover to the LGU the 2024 CBMS Data in electronic format, which may be through any of the mediums capable of encryption, such as but not limited to the use of an external storage device or electronic mail, provided that the LGU has provided the needed documents and information to the PSA as specified in the Agreement;

Whereas, the PSA and the Local Government of Botolan, Zambales agrees to perform their obligations and undertakings in accordance with the terms and conditions set forth in the Data Turnover Agreement for the effective implementation of the program;

Now therefore, on motion of Hon. Alfonso D. Lim, seconded by Hon. Doris D. Ladines, and approved by all the members in session assembled, be it:

Resolved, as it is hereby resolved, to authorize Hon. Jun Omar C. Ebdane, Municipal Mayor, to Enter into a Data Turnover Agreement with the Philippine Statistics Authority (PSA) Represented by its Undersecretary, National Statistician and Civil Registrar General, Claire Dennis S. Mapa, Phd., pursuant to Republic Act No. 11315 in the Establishment of Community-Based Monitoring System, this Municipality.
