RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH CENTRAL LUZON CENTER FOR HEALTH DEVELOPMENT (CLCHD) FOR THE IMPLEMENTATION OF THE INTEGRATED CLINIC INFORMATION SYSTEM (iClinicSys) IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES

Whereas, the 1987 Philippine Constitution declares that the State shall protect and promote the right to health of the people and instill health consciousness among them;

Whereas, the Department of Health (DOH) is promoting the Integrated Clinic Information System, a primary care electronic medical record system designed to improve data management, patient tracking, and the delivery of healthcare services at the local level;

Whereas, the Municipality of Botolan aims to modernize its health facilities and streamline clinical workflows to provide more efficient, accurate, and timely medical services to its constituents;

Whereas, the implementation of iClinicSys requires a formal partnership between the DOH-Central Luzon Center for Health Development and the Local Government Unit of Botolan define the roles, responsibilities, and technical support necessary for the system's success;

Whereas, pursuant to Section 444 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Municipal Mayor shall represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, upon authorization by the Sangguniang Bayan;

Now therefore, upon motion of Hon. Dr. Fernando D. Igrobay, duly seconded by Hon. Jay T. Dilag, and approved by all the members in session assembled, be it:

Resolved, as it is hereby resolved, to grant authority to Hon. Jun Omar C. Ebdane, Municipal Mayor, to enter into and sign a Memorandum of Agreement with the Department of Health Central Luzon Center for Health Development (CLCHD) for the implementation of the Integrated Clinic Information System (iClinicSys) in the Municipality of Botolan, Zambales.

Resolved further, that copies of this resolution be furnished to all concerned offices and agencies for their information and appropriate action.
