Whereas, the Honorable Municipal Mayor, being the Local Chief Executive, is duly authorized to represent the Municipality in entering into and signing such agreement;

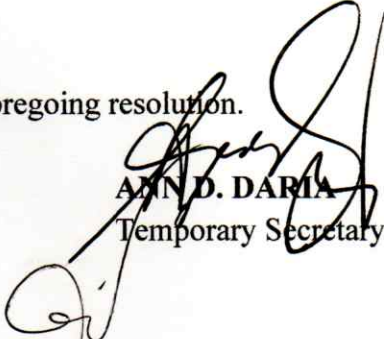
