RESOLUTION APPROVING AND CONCURRING THE DESIGNATION OF MS. MARY DESILOU M. ACADEMIA AS ACTING MUNICIPAL TREASURER OF THE LOCAL GOVERNMENT UNIT OF BOTOLAN, ZAMBALES EFFECTIVE JANUARY 29, 2026

Whereas, the Department of Finance, Manila, has issued Department Personnel Order No. 037-2026, designating Ms. Mary Desilou M. Academia as the Acting Municipal Treasurer for the Municipality of Botolan, Zambales;

Whereas, the position of Municipal Treasurer is vital to the local government's operations, involving the custody and proper management of public funds, the maintenance of a local tax information system, and providing technical advice to the Local Chief Executive and the Sangguniang Bayan;

Whereas, pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160) and existing civil service rules, the designation of a department head or acting Officer-in-Charge in a local government unit is a matter of administrative and legislative concern to ensure the continuity of public service;

Whereas, Ms. Mary Desilou M. Academia possesses the necessary qualifications, experience, and competence to lead the Municipal Treasury Office and uphold the financial integrity of the LGU;

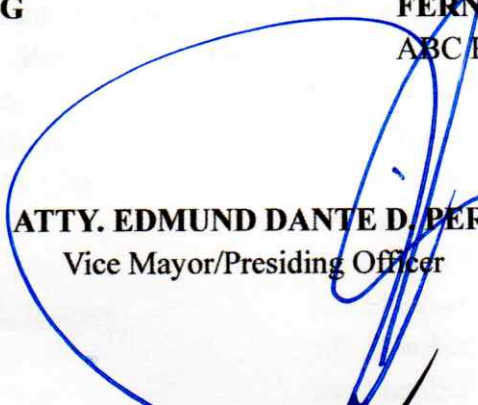
