EBDANE, MUNICIPAL MAYOR, TO TRANSACT, SIGN AND EXECUTE DOCUMENTS WITH THE ZAMBALES I ELECTRIC COOPERATIVE (ZAMECO I) RELATIVE TO THE APPLICATION FOR ELECTRICAL CONNECTION AND SERVICE INSTALLATION AT THE TWO-STOREY STANDARD PAGCOR MULTI-PURPOSE EVACUATION CENTER IN BARANGAY TAUGTOG, BOTOLAN, ZAMBALES

Whereas, the Local Government Unit (LGU) of Botolan, Zambales recognizes the urgent need to ensure the full operational capability of the two-storey standard PAGCOR Multi-Purpose Evacuation Center situated in Barangay Taugtog, Botolan, Zambales;

Whereas, the installation of electrical connection and energization of the said facility is vital for its effective use during times of calamities, disasters, and other emergency situations, as well as for community activities aligned with its purpose;

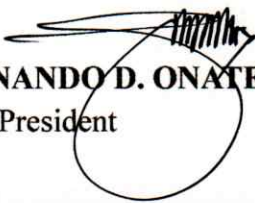
