RESOLUTION APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY OWAOG-NEBLOC MUNICIPALITY OF BOTOLAN, ZAMBALES FOR FISCAL YEAR 2026 IN THE AMOUNT OF ONE MILLION TWO HUNDRED EIGHT THOUSAND PESOS (P 1,208,000)

Whereas, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan is mandated to review and approve the annual budget of component barangays to ensure that the same are in conformity with existing laws, rules and regulations;

Whereas, the Supplemental Budget No. 1 of Barangay Owaog-Nebloc has duly enacted its Supplemental Budget No. 1 for Fiscal Year 2026 and submitted the same to the Sangguniang Bayan for review and approval;

Whereas, the proposed Supplemental Budget No.1 for Fiscal Year 2026 of Barangay Owaog-Nebloc amounts **One Million Two Hundred Eight Thousand Pesos (P 1,208,000.00)** to covering the estimated income and programmed appropriations for the effective delivery of basic services and implementation of development programs, projects, and activities of the barangay;

Whereas, after careful review, the proposed Supplemental Budget No. 1 of Barangay Owaog-Nebloc for Fiscal Year 2026 was found to be in accordance with the provisions of the Local Government Code of 1991, applicable budgeting laws, rules and regulations;

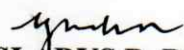

Resolved further, that copies of this resolution be furnished to all concerned offices and other agencies, for their information, favorable consideration, and appropriate action.

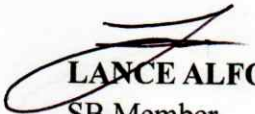
