RESOLUTION NO. 56A-2025

RESOLUTION ADOPTING THE ANNUAL INVESTMENT PLAN OF THE LGU-BOTOLAN FOR FISCAL YEAR 2026

Whereas, Section 106 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that each Local Government Unit shall have a comprehensive multi-sectoral development plan to be initiated by its Development Council and approved by the Sanggunian;

Whereas, the Annual Investment Plan (AIP) constitutes priority programs, projects and activities (PPAs) of the LGU to be funded for fiscal year 2026;

Whereas, the Annual Investment Plan which reflects the program of expenditures both for capital and current operating requirements of the Local Government Unit shall serve as a basis for the preparation of Annual and Supplemental Budgets pursuant to the provisions of Section 305 (g), (h), and (i) of the Local Government Code of 1991;

Whereas, there is a need to implement the programs, projects and activities of the Local Government Unit (LGU) in various sectors for the efficient delivery of public, social and economic services to the residents of Botolan and maintenance of peace and order in thirty one (31) barangays which are the major thrusts of the local administration;
