RESOLUTION REQUESTING MR. ASHER VINUYA, AREA COORDINATOR OF THE PHILIPPINE COCONUT AUTHORITY-ZAMBALES FOR TWO MILLION COCONUT SEEDLINGS TO BE USED FOR THE BANTAY GUBAT PROGRAM OF THE LOCAL GOVERNMENT UNIT IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES

Whereas, the Municipality of Botolan, Zambales, through its Local Government Unit, is continuously implementing programs aimed at environmental protection, reforestation, and sustainable livelihood for its constituents;

Whereas, the Bantay Gubat Program of the Municipality is a continuing initiative to protect, rehabilitate and preserve the forested areas and watersheds, particularly those affected by natural calamities and human activities;

Whereas, the planting of coconut trees is recognized as an effective measure in soil stabilization, carbon sequestration, and sustainable livelihood development, aligning with the objectives of the Bantay Gubat Program;

Whereas, the Philippine Coconut Authority (PCA), as the national agency mandated to promote the development of the coconut industry, provides technical and material assistance to local government units and farmers in the propagation of coconuts;
