RESOLUTION NO. 84-2026

RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF MIGRANT WORKERS, OVERSEAS WORKERS WELFARE ADMINISTRATION, DEPARTMENT OF LABOR AND EMPLOYMENT, TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY, OFW HOSPITAL, PROVINCIAL GOVERNMENT OF ZAMBALES, CITY OF OLONGAPO, AND MUNICIPALITIES OF IBA, CABANGAN, PALAUIG, SAN ANTONIO, MASINLOC, STA. CRUZ, SAN MARCELINO, SUBIC, CASTILLEJOS, SAN NARCISO, SAN FELIPE AND CANDELARIA, FOR THE IMPLEMENTATION OF GOVERNMENT PROGRAMS AND SERVICES FOR MIGRANT WORKERS AND ALL THE PROCESSES AND ASPECTS OF OVERSEAS EMPLOYMENT, IN THE ENTIRE PROVINCE OF ZAMBALES

Whereas, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates local government units to promote the general welfare of their inhabitants, provide basic services, and enhance economic prosperity;

Whereas, a significant portion of the constituency of the Province of Zambales consists of Overseas Filipino Workers (OFWs) and migrant workers who contribute immensely to the local and national economy through their remittances and hard work;

Whereas, there is an essential need to institutionalize, streamline, and converge the programs, services, and regulatory processes of various national government agencies, localized healthcare facilities, and local government units (LGUs) to ensure the protection, welfare and empowerment of migrant workers and their families;

Whereas, the Department of Migrant Workers, Overseas Workers Welfare Administration, Department of Labor and Employment, Technical Education and Skills Development Authority and the OFW Hospital, together with the Provincial Government of Zambales, the City of Olongapo, and the various Municipalities of the Province, have agreed to establish a collaborative framework through a Memorandum of Agreement (MOA);

Whereas, this joint initiative aims to bring government services closer to the grassroots, covering welfare cases, reintegration programs, skills training, healthcare access, and all critical aspects of the overseas employment process across the entire province;

Whereas, Section 22- c of the Local Government Code of 1991 requires prior authorization from the Sangguniang Bayan before the Municipal Mayor may enter into any contract or agreement in behalf of the Municipality;

Now therefore, upon motion of Hon. Eddie D. Daos, seconded by Hon. Dr. Fernando D. Igrobay, and approved by all the members in session assembled;

Be it resolved, as it is hereby resolved, to grant authority, as it hereby grants authority, to Hon. Jun Omar C. Ebdane, Municipal Mayor, to enter into and sign a Memorandum of Agreement with the following partner agencies and local government units for the comprehensive implementation of government programs and services for migrant workers and all processes and aspects of overseas employment in the entire province of Zambales:

1. Department of Migrant Workers (DMW)
2. Overseas Workers Welfare Administration (OWWA)
3. Department of Labor and Employment (DOLE)
4. Technical Education and Skills Development Authority (TESDA)
5. OFW Hospital
6. Provincial Government of Zambales
7. City of Olongapo
8. Municipalities of Iba, Cabangan, Palauig, San Antonio, Masinloc, Sta. Cruz, San Marcelino, Subic, Castillejos, San Narciso, San Felipe and Candelaria

Resolved further, that copies of this resolution be furnished to all the concerned offices and agencies for their information and appropriate action.

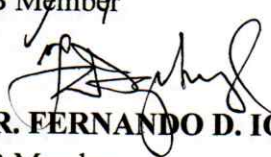

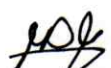
