RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO SIGN FOR AND IN BEHALF OF THE MUNICIPALITY ALL NECESSARY DOCUMENTS, CONTRACTS AND AGREEMENTS PERTAINING TO THE OPERATION, MANAGEMENT AND UTILITY CONNECTIONS OF THE NEW COMMERCIAL BUILDING LOCATED AT BARANGAY BATONLAPOC, BOTOLAN, ZAMBALES

Whereas, the Local Government Unit of Botolan has successfully completed/established the New Commercial Building located at Barangay Batonlapoc, an infrastructure project intended to stimulate local commerce and provide a centralized hub for economic activities;

Whereas, to ensure the full operation of the said building, there is a need to enter into various legal instruments, including but not limited to, Lease Contracts with prospective tenants, Service Agreements for water and electricity, and maintenance contracts;

Whereas, Section 22 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned;

Whereas, this Body recognizes the importance of granting this authority to the Municipal Mayor to facilitate the timely utilization of the building and to ensure that the economic benefits intended for the people of Botolan are realized without delay;

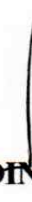

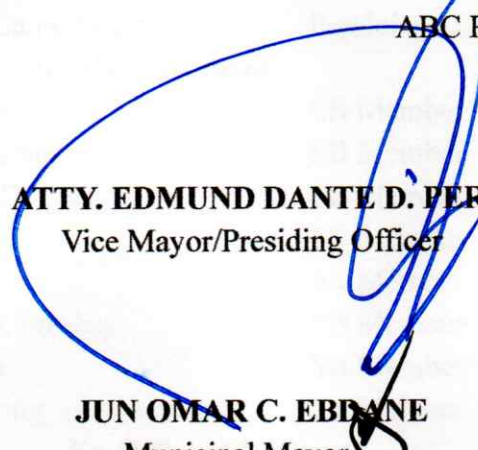
