RESOLUTION NO. 23-2026

RESOLUTION AUTHORIZING THE INCLUSION OF VARIOUS PRIORITY DEVELOPMENT PROJECTS IN THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN FOR CALENDAR YEAR 2026 AND APPROVING THE IMPLEMENTATION THEREOF

Whereas, the Municipal Development Council (MDC) has identified several urgent priority projects aimed at enhancing infrastructure, improving public service delivery, and promoting sustainable energy within the municipality;

Whereas, there is a critical need to upgrade the municipality's operational capacity through the purchase of various heavy equipment to support ongoing maintenance and disaster response efforts;

Whereas, the improvement of local road networks is essential for the economic mobility of our constituents, specifically the construction of roads in Barangay Mambog and Barangay Tampo, and the construction of a circumferential road at Kainomayan Village in Barangay San Juan;

Whereas, the municipality is committed to modernizing its governance and reducing its carbon footprint through the installation of a solar energy system at the Administrative Building and the enhancement of the Municipal Information System;

Whereas, these projects were not fully covered in the original Annual Investment Plan (AIP) 2026, necessitating their inclusion in a Supplemental Annual Investment Plan to facilitate the appropriation of necessary funds;

Now therefore, upon motion of Hon. Dr. Fernando D. Igrobay, duly seconded by Hon. Angel B. Diesta, and approved by all the members in session assembled;

Be it resolved, as it is hereby resolved, to authorize the inclusion of the following projects in the Supplemental Annual Investment Plan for CY 2026:

1. Infrastructure and Equipment Development

- Purchase of various heavy equipment: To bolster the engineering department's capability for infrastructure projects and calamity response – **Project Cost: P12,000,000.00**
- Barangay Mambog Road Project: Construction of local road networks to improve farm-to-market access – **Project Cost: P6,000,000.00**
- Kainomayan Village Circumferential Road in Barangay San Juan: Construction of a strategic loop road to ease traffic congestion and improve residential access – **Project Cost: P15,127,000.00**
- Barangay Tampo Road Project: Construction and paving of critical access roads – **Project Cost: P660,000.00**

2. Modernization and Sustainability

- Solar Energy Installation: Provision of renewable energy solutions for the Municipal Administrative Building to reduce utility costs. **Project Cost: P5,500,000.00**
- Municipal Information System (MIS): Digitalization of municipal records and streamlining of public service transactions. **Project Cost: P40,000,000.00**

Resolved further, that copies of this resolution be furnished to all concerned offices and agencies for their information and appropriate action.

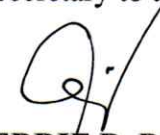
