**RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PRESIDENT RAMON MAGSAYSAY MEMORIAL HOSPITAL FOR THE ACCOMMODATION OF PATIENTS BEING REFERRED BY THE DR. FLORENTINO C. DOBLE MEMORIAL HOSPITAL WITH CASES OF ACUTE CORONARY SYNDROME, STROKE SYNDROME, ACUTE ABDOMEN, TRAUMA/ORTHOPEDIC INJURIES AND COMPLICATED OB-GYNE CASES**

**Whereas**, the Dr. Florentino C. Doble Memorial Hospital (DFCDMH) as the primary public healthcare facility of the Municipality of Botolan, continuously strives to provide quality healthcare services to its constituents;

**Whereas**, the hospital encounters limitations in handling highly specialized and emergency medical cases such as acute coronary syndrome, acute abdomen, trauma/orthopedic injuries and complicated OB-GYNE cases due to facility and equipment constraints;

**Whereas**, there is a compelling need to refer patients with such conditions to higher medical institutions capable of providing advanced and immediate care;

**Whereas**, the President Ramon Magsaysay Memorial Hospital in Iba, Zambales is a duly accredited and equipped government medical institution capable of accommodating such critical and specialized cases;

**Whereas**, the Municipality of Botolan recognizes the importance of formalizing a referral arrangement through a Memorandum of Agreement (MOA) with the President Ramon Magsaysay Memorial Hospital in Iba, Zambales to ensure the timely accommodation and treatment of patients requiring advanced medical care;

**Whereas**, the proposed MOA will support the municipality's commitment to safeguarding the health and lives of its constituents, especially in time-sensitive and life-threatening situations;

**Now therefore**, upon motion of Hon. Dr. Fernando D. Igrobay, seconded by Hon. Arthur R. Daria, and approved by all the members in session assembled be it;

**Resolved**, as it is hereby resolved, to grant authority to Hon. Jun Omar C. Ebdane, Municipal Mayor, to enter into a Memorandum of Agreement with President Ramon Magsaysay Memorial Hospital in Iba, Zambales for the accommodation of patients being referred by the Dr. Florentino C. Doble Memorial Hospital with cases of acute coronary syndrome, acute abdomen, trauma/orthopedic injuries and complicated OB-Gyne cases.

**Resolved further**, that copies of this resolution be furnished to Eileen Rose C. Garrido, M.D., MHA Chief of Hospital II of PRMMH and Chief of Hospital I of DFCDMH, Peter Allen S. Sescon, M.D., and other concerned agencies for their information and appropriate action.

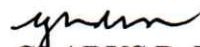

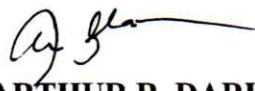

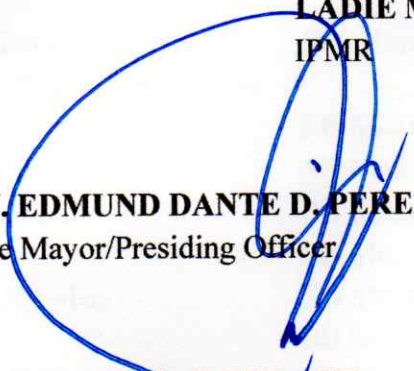
