RESOLUTION NO. 22-2026

RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE III, CITY OF SAN FERNANDO, PAMPANGA FOR THE TRANSFER OF FUNDS FOR THE IMPLEMENTATION OF CYCLE 16 SUPPLEMENTARY FEEDING PROGRAM IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES

Whereas, the Supplementary Feeding Program (SFP) is the provision of food in addition to the regular meal to target children ages 2-4 years old enrolled in the Child Development Centers (CDCs) and Supervised Neighborhood Play (SNPs) as part of the DSWD's contribution to the Early Childhood Care and Development (ECCD) program of the government;

Whereas, the Department of Education (DepEd) and the Department of Social Welfare and Development (DSWD) in consultation with other National Government Agencies (NGAs), Local Government Units (LGUs), Non-government Organizations (NGOs), and development partners, are mandated by Republic Act No. 11037 also known as "Masustansyang Pagkain Para sa Batang Pilipino" to promulgate their respective rules and regulations for the efficient and effective implementation of the National Feeding Program for Public Day Care Centers (PDCCs) or Child Development Centers (CDCs), public kindergarten and elementary schools, pursuant to Section 4 of the said law to address undernutrition among Filipino children;

Whereas, the effective and efficient implementation of a national feeding program shall sustain the gains of good nutrition achieved through the delivery of early childhood care and development services consistent with Republic Act No. 10410, otherwise known as the "Early Years Act of 2013" and quality basic education services under RA 10533, otherwise known as the "Enhanced Basic Education Act of 2013";

Whereas, the Department of Social Welfare and Development (DSWD) and the Local Government Unit of Botolan, Zambales will come up with respective roles and responsibilities with regards to the pre, during and post implementation of the program;

Whereas, the Local Government Unit of Botolan, Zambales had been targeted as area of implementation of the said feeding program tagged as Cycle 16 which will cover one thousand children-beneficiaries coming from 45 Child Development Centers (CDCs), within 180 days of implementation;

Whereas, in order to achieve a seamless and efficient process for the transfer and distribution of the program funds, it is imperative that LGU Botolan formalizes a clear, binding agreement with the DSWD. Such an agreement will serve as a legal framework that outlines the responsibilities, obligations, and procedures to be followed by both parties. Formalizing the partnership will facilitate the smooth transfer of funds, ensure compliance with national government policies and guidelines, promoting transparency and accountability in the process of distribution;

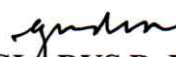

Be it resolved, as it is hereby resolved, to grant authority to Hon. Jun Omar C. Ebdane, Municipal Mayor, to enter into a memorandum of agreement with the Department of Social Welfare and Development (DSWD) for the implementation of the Supplementary Feeding Program for the 1000 children-beneficiaries;
