RESOLUTION NO. 56-2026

RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO APPLY FOR AND SECURE ELECTRIC CONNECTIONS WITH THE ZAMBALES I ELECTRIC COOPERATIVE, INC. (ZAMECO I) FOR THE SEVENTEEN (17) UNITS OF CLOSED-CIRCUIT TELEVISION (CCTV) CAMERAS TO BE INSTALLED IN STRATEGIC AREAS IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES

Whereas, the Municipal Government of Botolan is highly dedicated to maintaining public order, ensuring crime prevention, and strengthening the safety and security of its residents, visitors, and local businesses;

Whereas, as part of its ongoing peace and order initiatives, the municipality is deploying seventeen (17) units of Closed-Circuit Television (CCTV) cameras to be installed in various strategic public places and major thoroughfares across Botolan to aid in round-the clock monitoring and emergency response;

Whereas, for these security installations to become fully operational, there is a crucial need to connect them to a reliable electrical power source through the Zambales I Electric Cooperative, Inc. (ZAMECO I);

Whereas, ZAMECO I requires a formal authorization from the local legislative body authorizing the Local Chief Executive to apply for, sign contracts, and secure the necessary electrical connections for municipal public utilities and infrastructure;

Whereas, Section 22 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that no elective local official may enter into a contract, agreement, or deed of donation on behalf of the local government unit without prior authorization from the Sangguniang Bayan;

Now therefore, on motion of Hon. Fernando D. Onate, Jr., Chairman of the Committee on Peace and Order, duly seconded by Hon. Jessa Nicole B. Jaring, and approved by all the members in session assembled;

Be it resolved, as it is hereby resolved, by the Sangguniang Bayan of Botolan, Zambales, to authorize Hon. Jun Omar C. Ebdane, Municipal Mayor, to apply for, request and secure the required electric service connections with ZAMECO I for the seventeen (17) units of Closed-Circuit Television (CCTV) cameras to be installed in various strategic locations within the Municipality of Botolan.

Resolved further, that the Honorable Mayor is hereby empowered to sign, execute, and submit all necessary application forms, service contracts, and pertinent documents required by ZAMECO I to facilitate the immediate power connection and mobilization of the security cameras..

Resolved finally, that copies of this resolution be furnished to all concerned offices and agencies for their information and appropriate action.

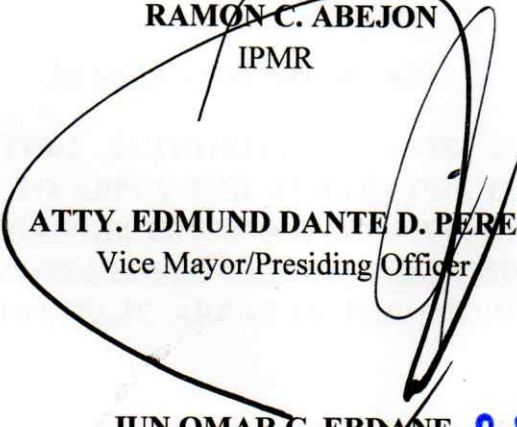
