RESOLUTION REQUESTING THE DEPARTMENT OF TRANSPORTATION TO CONSIDER THE APPLICATION FOR AVAILMENT OF FUEL SUBSIDY OF QUALIFIED TRICYCLE OPERATORS AND DRIVERS OF THE MUNICIPALITY OF BOTOLAN, ZAMBALES

Whereas, the Department of Transportation (DOTr) and the Department of Energy implement the Fuel Subsidy Program to assist qualified public transport operators and drivers in mitigating the impact of fluctuating fuel prices and economic challenges;

Whereas, tricycle operators and drivers in the Municipality of Botolan play a vital role in the local transportation system, providing accessible and affordable means of transportation for residents and visitors, particularly in remote and rural barangays;

Whereas, many tricycle operators and drivers have been significantly affected by the continuous rise in fuel prices, resulting in decreased income and difficulty in sustaining their daily operations;

Whereas, the Local Government Unit of Botolan, through its Tricycle Operators and Drivers Association has endorsed and facilitated the submission of necessary documents to the DOTr for the inclusion of qualified tricycle operators and drivers in the Fuel Subsidy Program;

Whereas, the Sangguniang Bayan deems it appropriate to formally request the Department of Transportation to consider and approve the application for availment of the fuel subsidy of qualified tricycle operators and drivers of Botolan, Zambales;
