RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PRESIDENT RAMON MAGSAYSAY STATE UNIVERSITY FOR THE TRAINING OF NURSING STUDENTS AT THE DR. FLORENTINO C. DOBLE MEMORIAL HOSPITAL, NTRA, TAUGTOG, BOTOLAN, ZAMBALES

Whereas, the President Ramon Magsaysay State University (PRMSU) is an educational institution dedicated to providing quality instruction and hands-on professional development, particularly in its Bachelor of Science in Nursing program, which requires actual clinical exposure to hone the skills of its students;

Whereas, the Local Government Unit of Botolan operates and manages the Dr. Florentino C. Doble Memorial Hospital located at NTRA, Taugtug, Botolan, Zambales, a healthcare facility equipped to serve as a vital training ground for aspiring health professionals;

Whereas, the LGU-Botolan recognizes the importance of collaborating with academic institutions to support the development of future healthcare workers, thereby contributing to the overall enhancement of the country's medical workforce;

Whereas, the LGU agrees and allows the affiliation and training of PRMSU nursing students within the said municipal hospital, subject to the strict adherence to established policies, procedures, and guidelines governing the affiliation and training of students. It also committedly pledges to provide a safe, supportive and conducive learning environment where the nursing students can maximize and safely enhance their clinical exposure under proper professional supervision;

Whereas, pursuant to Section 444 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Municipal Mayor needs authorization from the Sangguniang Bayan to enter into contracts and agreements in behalf of the municipality;

Now therefore, on motion of Hon. Dr. Fernando D. Igrobay, duly seconded by Hon. Jay T. Dilag, and approved by all the members in session assembled;

Be it resolved, as it is hereby resolved, by the Sangguniang Bayan of Botolan, Zambales, to grant authority, as it hereby grants authority to Hon. Jun Omar C. Ebdane, Municipal Mayor, to enter into a memorandum of agreement with the President Ramon Magsaysay State University for the training of nursing students at the Dr. Florentino C. Doble Memorial Hospital, NTRA, Taugtog, Botolan, Zambales.

Resolved further, that the implementation of the student training program shall at all times conform to health protocols, hospital regulations, and institutional policies to ensure both student development and uncompromised patient care.

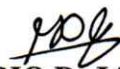

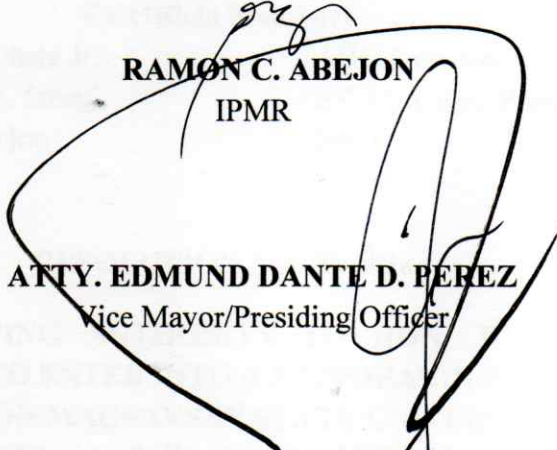

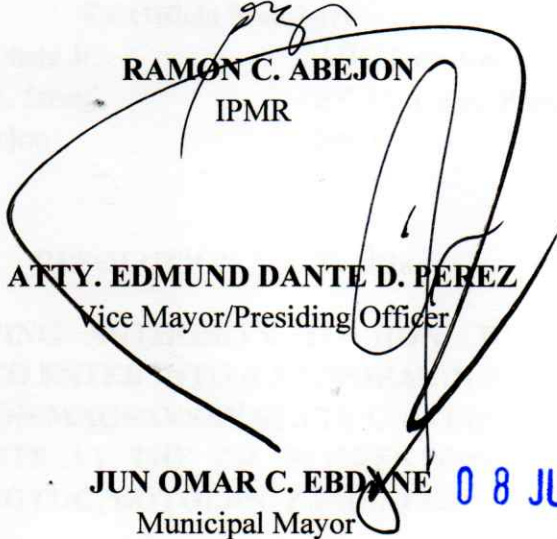
