RESOLUTION INTERPOSING NO OBJECTION TO THE ESTABLISHMENT AND OPERATION OF A POULTRY FARM OWNED BY MS. EVELYN R. CALMA IN PUROK 5, SAN JUAN, BOTOLAN, ZAMBALES

Whereas, the Municipal Government of Botolan, Zambales encourages and supports sustainable agricultural enterprises and livelihood projects that contribute to local economic growth, food security, and employment opportunities for its residents;

Whereas, Ms. Evelyn R. Calma has formally requested the local government unit for a resolution interposing no objection to the establishment and operation of her poultry farm business located at Sitio Mayamban, Purok 5, Barangay San Juan, Botolan, Zambales;

Whereas, the applicant has complied with the initial administrative prerequisites by submitting the pertinent documentary requirements to this August Body, to wit:

1. Application for Locational Clearance – confirming that the proposed site conforms with local zoning and land-use guidelines
2. Tax Declaration of Real Property – proving legitimate possession and/or ownership of the project site, and
3. Barangay Resolution No. 05-2026 issued by the Barangay Council of San Juan – expressing full community support and endorsement for the said poultry project

Whereas, upon careful review and assessment of the submitted documents and the endorsement of the host barangay, this Body finds that the project aligns with the development goals of the municipality, provided that all environmental and operational safety standards are strictly maintained;

Now therefore, on motion of Hon. Jay T. Dilag, duly seconded by Hon. Dr. Fernando D. Igrobay, and approved by all the members in session assembled;

Be it resolved, as it is hereby resolved, by the Sangguniang Bayan of Botolan, Zambales, to interpose no objection to the establishment and operation of the poultry farm owned by Ms. Evelyn R. Calma located at Sitio Mayamban, Purok 5, Barangay San Juan, Botolan, Zambales.

Resolved further, that this expression of No Objection is explicitly conditional upon the applicant's strict compliance with existing national laws and local ordinances.

Resolved finally, that copies of this resolution be furnished to all concerned offices and agencies for their information and appropriate action.

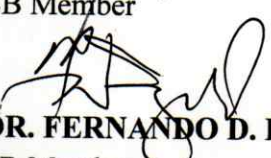
