**RESOLUTION CREATING THE MUNICIPAL COASTAL RESOURCE
MANAGEMENT BOARD OF BOTOLAN, ZAMBALES AND DEFINING ITS
COMPOSITION, POWERS AND FUNCTIONS**

Whereas, the Municipality of Botolan is endowed with rich coastal and marine resources that provide livelihood, food security and ecological balance;

Whereas, the protection, conservation, and sustainable management of coastal and marine resources are mandated under Republic Act No. 8550, as amended by Republic Act No. 10654, and Republic Act No. 7160;

Whereas, there is a need to strengthen coordination among local government units, national agencies, and stakeholders in the implementation of coastal resource management programs;

Whereas, the creation of a Municipal Resource Management Board will ensure participatory governance and effective policy direction in coastal resource management;

4. Promote sustainable livelihood programs for coastal communities
5. Monitor and evaluate coastal resource management initiatives
6. Recommend establishment and management of Marine Protected Areas (MPAs)
7. Strengthen community participation through IEC and capacity-building activities

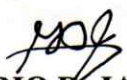

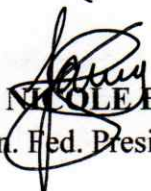
