RESOLUTION NO. 64-2026

RESOLUTION APPROVING ORDINANCE NO. 01-2026 OF BARANGAY PORAC, BOTOLAN, ZAMBALES ENTITLED "ISANG ORDINANSA NA NAGTATAKDA NA TANGING ANG ITINALAGANG BIOMAN LAMANG ANG MAY KARAPATANG MAGLAGAY AT MANGASIWA NG BASURA SA MATERIALS RECOVERY FACILITY, NAGBABAWAL SA PAG-UUTOS NG MGA BATA NA MAGTAPON NG BASURA, AT NAGPAPATAW NG MULTA SA SINUMANG LALABAG"

Whereas, Section 391(a)(1) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Barangay to enact ordinances necessary to discharge the responsibilities conferred upon it by law or ordinance and to promote the general welfare of the inhabitants therein;

Whereas, Section 447(a)(1)(i) /Section 458(a)(1)(i) of the same Code mandates the Sangguniang Bayan to review all ordinances approved by the Sangguniang Barangay to determine whether such ordinances are within the powers conferred upon them by law and in conformity with municipal ordinances;

Whereas, the Sangguniang Barangay of Porac submitted Barangay Ordinance No. 01-2026 for review and approval, which aims to institutionalize proper waste segregation, protect the well-being of minors, and ensure the orderly operation of their Material Recovery Facility (MRF);

Whereas, after careful review and evaluation by the Sangguniang Bayan, it was found that the provisions of Barangay Ordinance No. 01-2026 are within the scope of the prescribed powers of the Sangguniang Barangay and are consistent with Republic Act No. 9003 (Ecological Solid Waste Management Act of 2000) and existing child welfare laws;

Now therefore, upon motion of Hon. Doris D. Ladines, Chairman of the Committee on Environmental Protection, seconded by Hon. Eddie D. Daos, and approved by all the members in session assembled;

Be it resolved, as it is hereby resolved, to approve Ordinance No. 01-2026 of Barangay Porac, Botolan, Zambales Entitled "Isang Ordinansa na Nagtatakda na Tanging ang Itinalagang Bioman Lamang ang may Karapatang Maglagay at Mangasiwa ng Basura sa Materials Recovery Facility, Nagbabawal sa Pag-Uutos ng mga Bata na Magtapon ng Basura, at Nagpapataw ng Multa sa Sinumang Lalabag".

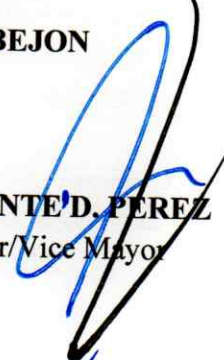

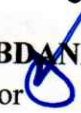
