RESOLUTION APPROVING AND ADOPTING THE ANNUAL INVESTMENT PLAN OF THE LGU-BOTOLAN, ZAMBALES FOR FY 2027

Whereas, Section 106 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its Local Development Council (LDC) and approved by its Sanggunian;

Whereas, the AIP for FY 2027 serves as the strategic framework for the allocation of public funds, containing the priority programs, projects and activities (PPAs) across various sectors namely General Public Services, Social Services, Economic Services and other Institutional Services;

Whereas, the proposed AIP integrates key development mandates, including the 20% Development Fund, Gender and Development (GAD) Plan, Local Disaster Risk Reduction and Management (LDRRM) Plan, Local Council for the Protection of Children (LCPC) Plan, Senior Citizens and Persons with Disabilities (PWDs) budget and other targeted statutory funds required by national guidelines;
