RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PRESIDENT RAMON MAGSAYSAY MEMORIAL HOSPITAL (PRMMH) FOR THE EXTENSION OF SERVICES FOR PATIENTS NEEDING LABORATORY TESTING WITH PROPER REFERRAL FROM THE DR. FLORENTINO C. DOBLE MEMORIAL HOSPITAL IN NTRA, TAUGTOG, BOTOLAN, ZAMBALES

Whereas, the Dr. Florentino C. Doble Memorial Hospital (DFCDMH) continues to provide accessible and quality healthcare to the residents of Botolan, Zambales;

Whereas, the hospital occasionally encounters limitations in its capacity to provide certain laboratory tests and diagnostics due to equipment availability, patient load or specialized requirements;

Whereas, there is a need to extend laboratory testing services through referral arrangements with private health facilities to ensure timely diagnosis and treatment for patients;

Whereas, the President Ramon Magsaysay Memorial Hospital in Iba, Zambales is a duly licensed and reputable medical institution equipped to provide laboratory services that may be needed by patients of DFCDMH;

Whereas, the proposed Memorandum of Agreement (MOA) between the Municipality of Botolan and the President Ramon Magsaysay Memorial Hospital in Iba, Zambales aims to formalize a referral-based partnership ensuring that patients in need of laboratory services may avail the same with appropriate endorsement from DFCDMH;

Whereas, entering into said MOA is in line with the municipality's commitment to strengthen local health systems and improve access to comprehensive diagnostic services;

Now therefore, upon motion of Hon. Dr. Fernando D. Igrobay, seconded by Hon. Arthur R. Daria, and approved by all the members in session assembled be it;

Resolved, as it is hereby resolved, to grant authority to Hon. Jun Omar C. Ebdane, Municipal Mayor, to enter into a Memorandum of Agreement with the President Ramon Magsaysay Memorial Hospital in Iba, Zambales for the extension of services for patients needing laboratory testing with proper referral from the Dr. Florentino C. Doble Memorial Hospital in NTRA, Taugtog, Botolan, Zambales.

Resolved further, that copies of this resolution be furnished to Eileen Rose C. Garrido, M.D., MHA Chief of Hospital II of PRMMH and Chief of Hospital I of DFCDMH, Peter Allen S. Sescon, M.D., and other concerned agencies for their information and appropriate action.

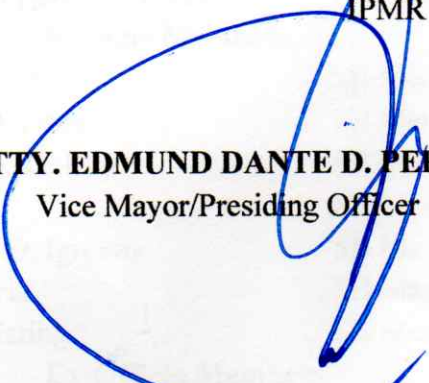
