RESOLUTION REQUESTING THE MANAGER OF THE LANDBANK OF THE PHILIPPINES-IBA BRANCH TO REACTIVATE THE ACCOUNTS OF POLYTECHNIC COLLEGE OF BOTOLAN-SENIOR HIGH VOUCHER PROGRAM (PCB-SHVP) WITH ACCOUNT NUMBER 1122-1087-47 AND NATIONAL HOUSING AUTHORITY (NHA) WITH ACCOUNT NUMBER 1122-1128-33 WHICH HAVE BEEN DORMANT FOR THREE YEARS

Whereas, the Local Government Unit of Botolan maintains a specific trust accounts with the Landbank of the Philippines-Iba Branch for national programs and educational subsidies;

Whereas, it has been determined that the following accounts have remained inactive for a period of three (3) years, resulting in their “dormant” status under bank regulations:

Whereas, the Senior High Voucher Program of the Polytechnic College of Botolan is an important government-supported program intended to assist Senior High School students through the provision of financial support coursed through an authorized bank account with the Landbank of the Philippines;

Whereas, the LGU-Botolan remains committed to complying with all bank requirements, including the submission of updated signature cards and necessary identification documents, to restore these accounts to active status;

Now therefore, upon motion of Hon. Doris D. Ladines, duly seconded by Hon. Dr. Fernando D. Igrobay, and approved by all the members in session assembled, be it:

Resolved, as it is hereby resolved, to respectfully request the Manager of the Landbank of the Philippines-Iba Branch to reactivate the accounts of Polytechnic College of Botolan-Senior High Voucher Program (PCB-SHVP) with Account Number 1122-1087-47 and National Housing Authority (NHA) with account number 1122-1128-33 which have been dormant for three years, subject to existing banking rules and requirements.
