**RESOLUTION NO. 03-2026**

**RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), FIELD OFFICE III, CITY OF SAN FERNANDO, PAMPANGA FOR THE TRANSFER OF FUNDS FOR THE IMPLEMENTATION OF SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES**

**Whereas**, the 1987 Philippine Constitution mandates the State to provide social security to the elderly and promote their well-being through various social protection programs;

**Whereas**, Republic Act No. 9994, otherwise known as the "Expanded Senior Citizens Act of 2010" provides for additional benefits and privileges to Filipino senior citizens in recognition of their contribution in nation building;

**Whereas**, one of the benefits and privileges of the seniors is the implementation of Social Pension for Indigent Senior Citizens where an eligible indigent senior citizen is entitled to a monthly stipend amounting to P1,000.00 per month in order to augment daily subsistence and other medical needs;

**Whereas**, the Department of Social Welfare and Development Field Office III, located in San Fernando City, Pampanga, is the lead agency responsible for the implementation of the Social Pension Program;

**Whereas**, in order to achieve a seamless and efficient process for the transfer and distribution of the stipend, it is imperative that LGU Botolan formalizes a clear, binding agreement with the DSWD. Such an agreement will serve as a legal framework that outlines the responsibilities, obligations and procedures to be followed by both parties. Formalizing the partnership will facilitate the smooth transfer of funds, ensure compliance with national government policies and guidelines, promoting transparency and accountability in the process of distribution;

**Whereas**, a Memorandum of Agreement (MOA) is necessary to define the roles, responsibilities and accountability of both the DSWD and LGU-Botolan in the fund utilization and liquidation process;

**Now therefore**, upon motion of Hon. Dr. Fernando D. Igrobay, seconded by Hon. Arthur R. Daria, and approved by all the members in session assembled be it;

**Resolved**, as it is hereby resolved, to authorize Hon. Jun Omar C. Ebdane, Municipal Mayor, to enter into a Memorandum of Agreement with the Department of Social Welfare and Development (DSWD), Field Office III, City of San Fernando, Pampanga for the transfer of funds for the implementation of social pension for Indigent Senior Citizens in the Municipality of Botolan, Zambales.

**Resolved further**, that copies of this resolution be furnished to all concerned offices and agencies for their information and appropriate action.

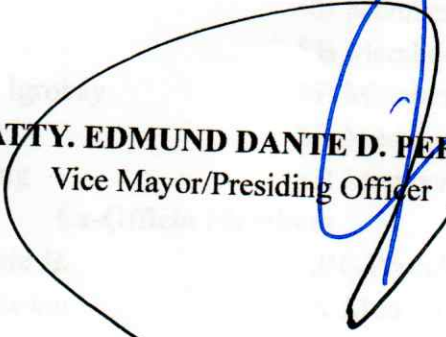
