RESOLUTION APPROVING THE IMPLEMENTATION OF THE FY 2026 LOCAL GOVERNMENT SUPPORT FUND FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FALGU) TO INDIGENT INDIVIDUALS OR FAMILIES FOOD ASSISTANCE (AIFF-FA) – RICE DISTRIBUTION PROJECT IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES, IN THE AMOUNT OF FIVE MILLION PESOS (P5,000,000.00)

Whereas, the Department of Budget and Management (DBM) and the Department of the Interior and Local Government (DILG) issued Joint Circular No. 01-2026 dated February 19, 2026, prescribing the guidelines for the implementation of the FY 2026 Local Government Support Fund Financial Assistance to Local Government Units (LGSF-FALGU);

Whereas, under the said joint circular, local government units are eligible to receive financial assistance for various programs, including food assistance to indigent individuals or families to address food security and mitigate economic hardships;

Whereas, the Municipality of Botolan has been allocated a funding endorsement from the DBM amounting to Five Million Pesos (P5,000,000.00) specifically intended for the Indigent Individuals or Families Food Assistance (AIFF-FA)- Rice Distribution Project;

Whereas, this Honorable Body recognizes that the distribution of rice assistance will directly benefit low-income households, marginalized sectors, and indigent families across the various barangays of Botolan, ensuring immediate relief and social protection;

Whereas, to facilitate the release, receipt and utilization of the said funds, and to ensure full compliance with the procurement, accounting and auditing rules of the government, there is an urgent need to formally approve the implementation of the project;

Now therefore, on motion of Hon. Dr. Fernando D. Igrobay, duly seconded by Hon. Eddie D. Daos, and approved by all the members in session assembled;

Be it resolved, as it is hereby resolved, by the Sangguniang Bayan of Botolan, Zambales, to approve, as it hereby approves, the implementation of the FY 2026 Local Government Support Fund Financial Assistance to Local Government Units (LGSF-FALGU) to Indigent Individuals or Families Food Assistance (AIFF-FA) – Rice Distribution Project in the Municipality of Botolan, Zambales, in the amount of five million pesos (P5,000,000.00).

Resolved further, that the Municipal Mayor, Hon. Jun Omar C. Ebdane, be authorized to sign, execute, and deliver any and all documents, agreements, or certifications necessary for the successful rollout and completion of this project in accordance with DBM-DILG Joint Circular No. 01-2026.

Resolved finally, that copies of this resolution be furnished to all concerned offices and agencies for their information and appropriate action.

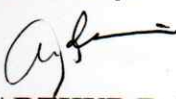

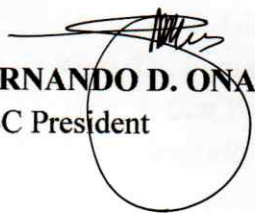

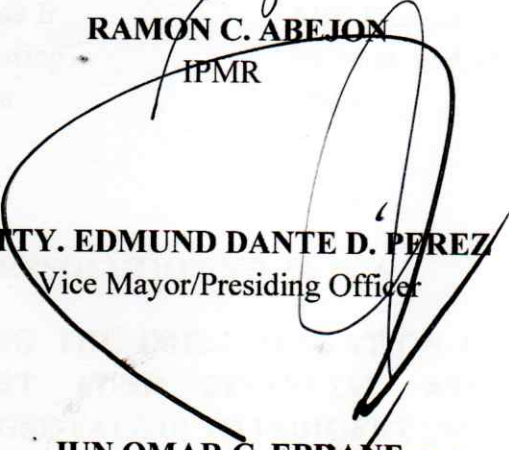
