RESOLUTION APPROVING THE ANNUAL BUDGET OF BARANGAY, POONBATO MUNICIPALITY OF BOTOLAN, ZAMBALES FOR FISCAL YEAR 2026 IN THE AMOUNT OF FOUR MILLION TWO HUNDRED FORTY-ONE THOUSAND TWO HUNDRED NINETEEN PESOS (P 4,241,219.00)

Whereas, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan is mandated to review and approve the annual budget of component barangays to ensure that the same are in conformity with existing laws, rules and regulations;

Whereas, the Barangay Poonbato has duly enacted its Annual Budget for Fiscal Year 2026 and submitted the same to the Sangguniang Bayan for review and approval;

Whereas, the proposed Annual Budget for Fiscal Year 2026 of Barangay Poonbato amounts **Four Million Two Hundred Forty-One Thousand Two Hundred Nineteen Pesos (P 4,241,219.00)** to covering the estimated income and programmed appropriations for the effective delivery of basic services and implementation of development programs, projects, and activities of the barangay;

Whereas, after careful review, the proposed Annual Budget of Barangay Poonbato for Fiscal Year 2026 was found to be in accordance with the provisions of the Local Government Code of 1991, applicable budgeting laws, rules and regulations;
