EBDANE, MUNICIPAL MAYOR, TO SIGN THE FUNDS DISBURSEMENT SERVICE, IMPLEMENTING AGREEMENT FOR GCASH POWERPAY PLUS SERVICE, IMPLEMENTING AGREEMENT FOR BILLERS, MOBILE PAYMENT SOLUTIONS AGREEMENT AND NON-DISCLOSURE AGREEMENT BETWEEN G-XCHANGE, INC. AND THE MUNICIPAL GOVERNMENT OF BOTOLAN, ZAMBALES FOR THE AVAILMENT OF DISBURSEMENT SERVICES, BILLS PAYMENT AND ONLINE PAYMENT SERVICES OF GCASH MOBILE PAYMENT SOLUTIONS IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES

Whereas, G-Xchange Inc. handles electronic money (e-money) issuance, remittance services and mobile payment solutions using Globe's network as transport channel under Gcash brand;

Whereas, the Municipality desires to avail the services of G-Xchange Inc. to accept and collect payments from its clients who are registered to Gcash through the transport channels;

Whereas, under Republic Act No. 7160 otherwise known as the "Local Government Code of 1991" Sec. 455 (b)(1)(vi), no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned and the Municipal Mayor shall represent the Municipality in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Bayan or pursuant to law or ordinance.

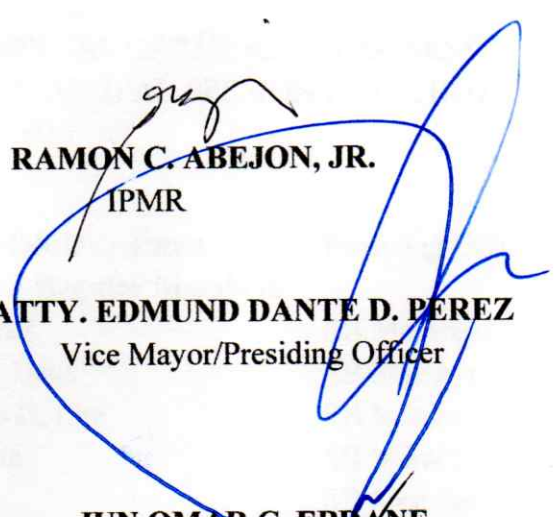
